This is a clinic to get you ready for the show season. You will ride your Dressage Test of Choice. The Judge will score your first ride and give you feed back. After that you will get to ride the test again to improve your score. Each ride will be approximately a half hour. The best of your scores will count towards the year end high point.

DRESSAGE CLASSES:

1. USEA 2010 Dressage – Test of Choice (40 x 20 arena)
2. USDF Intro – Test of Choice (Specify Test A and/or B)
3. Quadrille – Test of Choice (USDF 2007 Tests & CD if applicable)
4. Training Level – Test(s) of Choice (Specify Test 1, 2, 3)
5. First Level – Test(s) of Choice (Specify Test 1, 2, 3)
6. Second Level or above – Test(s) of Choice
7. Western Dressage – USDF Test(s) of Choice
8. Pas de Deux – English & Western. Open. Max time 8 min. Submit pattern w/entry & CD if applicable.
9. Quadrille Freestyle. (Submit pattern with entry)
10. Musical Freestyle. (Submit pattern & CD with entry)

SCHEDULE: Start time is 9 am. Show management reserves the right to cancel, combine, or split classes. Classes will be judged according to USEF and USDF rules where applicable.

ENTRIES: Make checks payable to Moss Beach Ranch. Mail to MBR, PO Box 24, Moss Beach, Ca 94038, or deliver to Moss Beach Ranch on or before close date. Mailed entries **MUST** be postmarked on or before April 13, 2012. **Entries close on April 15, 2012.** Entries are on a first-come, first-serve basis. Post entries will be accepted only as space allows. For questions call: 650-224-1922. No refunds unless veterinarian's/doctor's certificate is supplied.

FEES: \$70 per dressage test. \$40 per rider for Quadrille and/or Pas de Deux. Drug fee of \$5 per horse is mandatory.

TIMES: Times will be emailed and posted on the Moss Beach Ranch web site at www.mossbeachranch.com. It is the responsibility of the rider to contact show management if times are not received.

PRIZES: Scores count toward the Coastside Dressage Schooling Show Series Year-End Award Program, provided that the rider is a CDS member, or joins CDS at this show. Membership forms and award program information are available at the show or visit the San Francisco Peninsula Chapter, California Dressage Society, web site at www.sfpccds.com.

HORSES: All horses must have up-to-date vaccinations. Braiding is not required but is appreciated. Please clean up after your horse; dispose of manure in appropriate containers. Horse must be under rider's control at all times.

RIDERS: Regulation show attire is not required but is appreciated. Helmets and boots with heels **ARE** required for all riders.

TRAILER PARKING: Please park trailers **ONLY** in designated areas. Maintain a safe distance from other trailers and horses at all times.

VISITORS: Visitors are welcome. Please park **ONLY** in designated areas. Keep a safe distance from horses at all times.

DOGS AND CHILDREN: Please leave pets at home. Children must be supervised by an adult at all times.

I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering or death ("Harm").
- To release Moss Beach Ranch, Pacific Sport Horse Training LLC, and CDS from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of people or persons connected to this Competition.
- To expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of any agents of Moss Beach Ranch, Pacific Sport Horse Training LLC, and CDS .
- To indemnify (that is to pay any losses, damages, or costs incurred by) Moss Beach Ranch, Pacific Sport Horse Training LLC, and CDS and to hold them harmless with respect to claims for harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.
- That I understand that I am entitled to wear protective equipment without penalty and I acknowledge that I am hereby strongly encouraged to do so while WARNING that no protective equipment can guard against all injuries.
- If I am a parent or guardian of a junior competitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.
- That "Moss Beach Ranch, Pacific Sport Horse Training LLC, and CDS" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers, and affiliated organizations.
