- **Entry Deadline.** All DRESSAGE entries and fees must be received by **Monday October 23rd.**
- Send completed entry forms together with all fees to Moss Beach Ranch, % Karen DiLena, 1257 A Lerida Way, Pacifica, CA 94044
- Dressage classes start at 9:00 a.m.; class order is at the discretion of show management.
- For Pas de Deux, Quadrille, Musical Freestyle, and Western Dressage, riders must submit pattern w/entry & CD/thumbdrive if applicable. Email kpep22@yahoo.com or call (650) 224-2798 with any questions before submitting entry.
- All visiting horses must have up-to-date vaccinations.
- General US Equestrian Federation and USEA Rules apply.
- A "Western Dressage" option is available: USDF tests are ridden with Western tack and judged on western gaits.
- In Test of Choice, horse/rider combination may enter more than one test per class.
- Ribbons are awarded for 1st to 5th place
- Dressage tests are scored and ribbons awarded based on percentages.
- Dressage scores from this show will count toward the **MBR Dressage Schooling Show Series** Year-End Award.
- The Show Management reserves the right to cancel, combine, or split classes when warranted.
- Entry fees are non-refundable unless a doctor's restriction or veterinarian's certificate is provided.
- Please clean up after your horse. Do not litter!
- Trailer and car parking is limited. Please park **ONLY** in designated areas.
- You may use the ranch hitch racks to tie your horses. Do not tie to fences--use tie strings at all times!

Assumption of Risk, Waiver, and Indemnification

I agree in consideration for participation in this Moss Beach Ranch sponsored equine competition to the following:

- That I choose to participate voluntarily in this Equine Competition as a rider, lessee, owner, agent, coach, trainer, or as a parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering or death ("Harm").
- To release Moss Beach Ranch from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of people or persons connected to Moss Beach Ranch.
- To expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of Moss Beach Ranch.
- To indemnify (that is to pay any losses, damages, or costs incurred by) Moss Beach Ranch and to hold them harmless with respect to claims for harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Competition.
- That I understand that I am entitled to wear protective equipment without penalty and I acknowledge that Moss Beach Ranch strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.
- If I am a parent or guardian of a junior competitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf. _____ (initial)
