- Lesson Horse fee: \$40 for use of Moss Beach Ranch lesson horse. Leasees are not required to pay fee.
- All Classes will be ridden in numerical order unless otherwise posted on day of show.
- Show Management reserves the rights to cancel, combine, or split classes when warranted.
- All riders under age 18 must wear ASTM certified helmets.
- Entry fees are non-refundable unless a doctor's restriction or veterinarian's certificate is provided.
- Face coverings are required for all non-mounted attendees at all times. Please observe social distancing measures while on-site.
- Please clean up after your horse. Do not litter!
- Keep small children supervised for their safety.
